

POLICY CHANGES TO KNOW

BUILDING POLICY- Previously square footage was limited to 1200 square foot living space to include decks and buildings, an additional 400 square foot was also available for a carport. That has since been revised to 1600 total accumulated square footage for single lots, and 2400 for combined lots. Height restrictions have also changed. All structures, regardless of purpose, will be limited to, and must not exceed 16 feet from the highest point of the structure to the highest point of ground contact.

ULMV AGE REQUIREMENTS AND RESTRICTIONS- the rules for ULMV drivers have changed. You must still be 12 to drive with an adult in the FRONT seat. NO child under that age should be driving PERIOD! Opererators 15 years of age, carrying with them a valid state issued ID, will be permitted to operate without adult supervision. Please keep in mind this is a privilege, and not a right, and golf cart violation fee has been increased from \$30 to \$50. Please be responsible and effectively monitor and manage your drivers. They provide us with fun enjoyable transportation, but have resulted in serious injuries when carelessly operated.

GUEST LIST WITH SECURITY- We no longer offer the guest list service with security. Members should make arrangements with expected guests to contact them prior to arrival in order to meet them and receive them at the gate. This allows security to effectively provide increased service throughout the park as necessary. DO NOT AT ANYTIME SWIPE YOUR CARD TO ALLOW ACCESS FOR SOMEONE YOU DO NOT KNOW.

MAILBOXES

The mailboxes located out front are for WildRidge full time or snowbird residents only. You MUST go through the office to put one there. No mail is to be delivered to the WildRidge address other than large packages. The WildRidge address is not to be used as your permanent mailing address. If you have any questions, please see the manager before purchasing your mailbox.

WILDRIDGE REMINDERS FOR EVERYONE



- Stickers are required for all golf carts/ULMVs. \$20 each with proof of current liability insurance is required. Renewable yearly by July 1
- ⇒ ULMV drivers must be 15 years of age with a valid state issued ID in possession while operating. Drivers 12 years of age and older, to include 15 years with no ID are required to operate with an attentive, responsible parent or guardian in the front seat.
- ⇒ Effective July 1, 2017, Indiana Law requires operators or passengers under the age of 18 to wear a helmet on any ATV operated on public or private property. Golf carts are exempt from this requirement.
- Pool is swim at your own risk. Children 12 years of age and younger must be accompanied by an adult or guardian over 18 years of age.
- Shelterhouse is available to rent with a \$30 deposit, refundable after cleaning by renter. Contact the office to schedule.

Wildridge maintains a "Lots for Sale" list which is frequently updated. We also have the capability to list your lot on the Web site if you

- ⇒ so choose. Please contact the Park Manager to list your lot.
- All dues must be paid by June 30th each year to prevent collection proceedings, additional fees & suspension of priviledges.
- ⇒ **Dumpster hours** are 8:00 a.m. until dusk each day.
- ⇒ The security gate will close after each vehicle. Do not follow another vehicle through the gate. A MINIMUM \$250.00 fee will be charged for detaching the gate. Be sure to advise your guests.
- Pets must be kept on a leash or on your own lot. Please be a responsible pet owner and pick up after your pet.
- ⇒ Never leave a camp fire burning when you leave the park.

A NOTE FROM THE MANAGER

Well, we are experiencing another great busy year here at Wildridge. We are seeing improvements being done everywhere you look, and that's something for us all to be proud of!

Just a few things which need to be addressed, and brought to the attention of our members. The trash compactor at the service area is there for everyone's convenience. This equipment is in place to compact regular household trash, not to compact building materials, lawn furniture, or unwanted items you no longer want around your camp. Disposing of other than household trash creates excessive work for park staff and other members who are inconvenienced and go out of their way to help remove jammed up improper material in the compactor. There will be a \$100.00 fine applied to those members lot who violate this policy, or sit items they no longer want in, on or around the compactor. We diligently work to keep this area clean and presentable for our members, and we would appreciate the assistance in doing so.

In regards to the entrance security gate, only one vehicle at a time is permitted. The gate must close completely before carding again to open it. The gate will not accept another card reading and stay open until it closes completely. This may help some of those who did not understand how the system operated.

Please be mindful while operating any mode of transportation throughout the park. The speed limit is 15 mph for all vehicles. We do our very best to keep our members and their family safe to allow all members to enjoy their time at Wildridge. Speeding is not necessarily age group specific, so please be mindful and pass this information along to your guest and family who are sharing the roadways with others, as common courtesy goes a long way in allowing everyone to have a great day.
