

# WILDRIDGE ASSOCIATION, INC. 2025 ANNUAL MEMBERSHIP DUES

The 2025 Dues will be \$1250.00 per lot. This rate is the same as the 2024 Dues. We strive to maintain our membership dues at the lowest possible rate, while maintaining our infrastructure, services and facilities. Wildridge began a paving project in 2023, and have continued this each year. We will continue this improvement in 2025 in an effort to provide a better infrastructure for our community.

**Annual Dues:** Monthly dues payments are accepted and must be paid in full by **June 30, 2025**. A credit of \$10.00 will be given for each month for early payment in full prior to June 1, 2025, with a maximum discount of \$60.00. For your convenience credit cards and E-check payments are now being accepted as well. There is a 4% convenience fee for credit/debit cards. Members may make payments toward their current or future dues providing that dues balances are paid prior to due date. **Important Notice:** Members with unpaid dues as of **July 1, 2025**, will be considered in default of the lease. Wildridge will charge a late fee of \$30 per month for the months of July, August, and September. If by **October 1<sup>st</sup>** no payment arrangements are made that will satisfy the balance by **12/31/25** the account will be turned over to our attorney for collection up to an eviction and termination of lease. Members may send advanced weekly/monthly payments toward their current dues/next year dues for those who choose to do so.

**ULMV Tags for 2025:** 2024 tags will expire **June 30, 2025**. Lot numbers must be displayed on all ULMV's visible from the rear. BEGINNING ON THE 2025 TAGS, ALL ULMV'S WILL BE INSPECTED FOR DISPLAYED LOT NUMBERS PRIOR TO PICK UP OF A NEW TAG. Remember that all scooters, golf carts and ATV's/UTV's not displaying an Indiana state license plate must display a Wildridge ULMV tag (purchased annually) prior to operation of these vehicles, reminder that Indiana DNR licenses and/or Indiana ORV tags do not qualify or negate the requirement. This policy will continue to be strictly enforced. Cost of the tag is \$20. **At the time of purchase, members are required to present proof-of-liability insurance stating that the vehicle is covered on the policy, also members must be in good standing.** This means that all financial obligations must be paid up to date before you will be allowed to purchase stickers. You may purchase your tag by mail. Please enclose an updated copy of your insurance policy along with your dues. Members may pre-pay for ULMV tags with dues, please note on the check that the amount is for both dues and ULMV tag. Our manager will hold the tag for you until your first visit back to WildRidge.

We no longer mail newsletters and updates. Communications regarding rule changes and updates are made through social media such as Facebook and the newsletter which is posted on the website. Hardcopies are also available in the office. You are always welcome to attend the monthly board meetings held the second Saturday of each month. It is your responsibility to stay informed.

Effective January 1, 2019, those individuals operating scooters or mopeds on Wildridge property must be 15 years of age with a valid state issued identification in their possession, and if under the age of 18 are required to wear a helmet. Golf carts and ULMV's may be operated by individuals 15 years of age and having in their possession a valid state issued identification. Golf carts and ULMV's may be operated by driver's at least 12-14 years of age, provided they have a responsible parent, guardian, or adult in the front seat with them while operating the ULMV. ULMV operation in Wildridge is a privilege and not a right, so please drive responsibly so that all may enjoy all the park has to offer...

- **LOT NUMBERS MUST BE DISPLAYED VISIBLY ON CAMPS AS TO BE EASILY NOTICED FROM THE ROADWAY, AS WELL AS DISPLAYED ON ALL ULMV'S VISIBLE FROM THE REAR.**
